Assn. Board Highlights

March 18, 2013

Kelly Rogers, Attic Angel Community Senior Living Consultant, was the guest speaker at this month's Board meeting. Her primary focus is working with the public and the wait list. Kelly works on filling every level of care except the Health Center. With the new expansion nearly finished, she is busy filling those units. Currently, the Household is full and the Haven is always full. As apartments become available, they are being renovated with quartz countertops and new flooring in the kitchen and bath areas, to make them more desirable. The only units available at Prairie Point are three units under construction and two re-lease units. Kelly frequently hears how the Attic Angel Community is highly regarded, and finds the biggest source of new resident referrals is the membership, which is greatly appreciated.

Other actions by the Board included:

- Accepting the recommendation of the Fund Allocation Committee to use surplus funds to raise community grants to \$48,573 to include Dane County CASA as well as the Children's Service Society of WI, and \$48,000 for Resident Aid.
- Approving permanent recognition for McKenzie Circle donor Phillipina Lankelma which will be accomplished through naming of the Rehab Therapy Center.
- Approving the appointments of the Chairs and their Assistants as recommended by the Nominating Committee.
- Approving the acceptance of three new members on the recommendation of the Membership committee.

The Board also discussed feedback from the Leadership Forum where the main topic was how to deal with the population shift among our residents and how our Angels serve them. A number of suggestions were made at the Forum and will need to be studied further to determine the best solution.

At the conclusion of the meeting, the Board was given a tour of one of the newly remodeled and upgraded apartments.

Mary Ann's Musings

National Exposure: Attic Angel's light is too bright for just local renown. We were included in the US News and World Report as one of the top nursing homes in the country, due to the Center for Medicare and Medicaid Services' five star rating program. We will also be featured in the national e-magazine Business World Magazine for our efforts to provide quality resident services, and we will be among a few projects featured for our expansion project at the national annual meeting of Fire Alarm and Life Safety Equipment Distributors in April. Thanks to our strong triad of residents, staff and volunteers; we have great news to share with the nation about how to "do it right"!

Long Term Care Occupancy Rates: According to the National Investment Center for the Senior Housing and Care Industry, occupancy rates are 89% in independent living settings; 89.1% in assisted living; and 88.1% in nursing facilities. These are increases over prior quarters, which is beneficial to the industry. At Attic Angel, our occupancy rates are 93% in independent living (Prairie Point); 93.4% in assisted living (Apartments, Households and Haven); and 88.8% in our nursing facility (Health Center). We have surpassed all these national averages due to the excellent coordination of efforts – admissions staff who call referral sources and provide effective tours, nursing staff who provide prompt assessments and the type of quality care that attracts new residents, maintenance and housekeeping staff who quickly refurbish units so they are ready for new residents, and of course marketing efforts of all the staff, residents and volunteers who provide such effective wordof-mouth advertising for the community. Go ahead, and give each other an appreciative pat on the back!

<u>Sale of Land</u>: In addition to the \$2.6 million the Association donated to Prairie Point to enable the development of our wonderful senior housing community, there have been monies loaned over the years, totaling \$1.9 million at this time. To help reduce this debt, Prairie Point has decided to sell the 2.7 acre parcel of land known as 8552 Elderberry Road to the Association. The land has been appraised at \$1.2 million, but because the responsibility to construct Elderberry Road-Phase 2 will be transferred with the land, the net value is \$700,000. By enacting this sale of land, it allows the Association greater balance with their investments, rather than having so much tied up in the loan; it allows Prairie Point to reduce the interest expense on the loan – as well as relieving it from the liability of the cost to construct the second phase of Elderberry Road. This also keeps the land asset "in the family", so when Prairie Point is in a better financial position, it could purchase the land back and continue with the plans for senior apartments. This is a great example of a win / win situation between corporations. Congratulations to the Boards of each corporation for your vision and action!

Budgets Approved: The Association budget was approved with a cash deficit of \$59,839. The cause of the deficit is to assist Attic Angel Prairie Point, Inc. Prairie Point had agreed more than a decade ago to pay for the completion of Elderberry Road when we constructed either of the two apartment buildings planned as part of Phase 3. Our plans have run into numerous obstacles, not the least of which was the Great Recession, so Phase 3 apartments are not being considered at this time. The City of Madison, however, has determined that Elderberry Road is necessary now, and they will begin the first phase of completing that road within the next couple of months. Prairie Point does not have the financial capacity to pay for the road, even though the city is allowing us to pay it back over a 15 year period. Therefore, the Attic Angel Association has agreed to make the first yearly payment as a gift (approximately \$74,000), and will consider subsequent years' payments until Prairie Point has the financial wherewithal to fund it themselves. It should be noted there is a cash surplus for the 2012-13 fiscal year that will more than cover the deficit for next year.

The Attic Angel Place budget was approved with a rate increase of 3% for the Health Center, 3% for the Apartments, 2% for the Haven, and 2-4.3% for the Households. This was a difficult budget, with the addition of the 20 Household units, and having to make assumptions about the rate at which they would be occupied, staffed, etc. We are also providing new service packages for the Apartments, to increase the amount of care and services residents can receive in that area.

The Attic Angel Prairie Point budget was approved with new options of monthly fees and refund percentages for current and new residents. Offering these options allows residents to conserve current expenses, if that is a priority for them. The total budget has an overall net cash gain of \$11,932, (operating budget has a projected cash loss of \$110,124 and development budget has a projected cash gain of \$122,056).

Thanks to the diligent efforts of the Department Heads, notably Marcie Vaage and her Finance team, we have sound budgets that reflect our mission and priorities of providing excellent care while being good stewards of our resources!

The Executive Director of the Center, Becky Steinhoff, along with the Development Director Rohan Barrett and the Program Director, Dondieneita Fleary-Simmons, will be the featured speakers at the Education Program on Wed., April 10, at 9:30.

Becky, Rohan and Dondieneita will give us an overview of the Center's mission and goals and tell us how our donation will help them achieve these goals. The presentation will include audio and video stories of people whose lives are impacted by services the Center provides. There will also be an opportunity to ask questions of our guests at the end of the talk.

Becky has been the Director of the Goodman Community Center since 1991. During her tenure the Center has grown from a budget of less than \$200,000 and 2.5 employees to its current annual operating budget of \$4 million and 60 employees!

We know how hard each Angel works helping members of our Attic Angel community and planning and hosting fundraisers. The Planning and Outreach Committee hopes you will attend this event to learn how our contributions to the Goodman Community Center help make Madison a better place to live.

This will be the second year in a row that I have headed up the Linens department of the annual Attic Sale.

During my Intern year, I explored something called a 'pack'. It sounded like a wolf pack or a pack of cards to me. Naturally I was curious. My goodness! The first day I attended a 'pack', I discovered a flurry of activity in the main storage area in the basement of the Angel Offices. Lots going on, lots of folks doing lots of things. I wandered back into the linens area. It was relatively quiet, peaceful and out of the way. I felt I could learn a little more slowly about this section of the Sale, sort of take my time! In this section I discovered a large table area, stacked with all sorts of sheets, blankets, pillows, pillow cases, and towels. It seemed straightforward enough to fold and price rectangular

things so I decided to try the linen department. Organization is something I enjoy. I began organizing! And I began folding, and I began pricing.

The first person I met was Flossie Griswold. Now Flossie is a force to be reckoned with. She knows all of the important things about linens. So



Flossie became my teacher. We enjoyed many hours of cleaning when necessary, folding, pricing, and packing.

My next teacher was Sandy Spengler. She is not only an expert about vintage linens, something we receive a lot of,

she is also a display and retail person extraordinaire. Sandy and Flossie can singlehandedly set up a space for the Sale and make it attractive as well as accessible. So, no way to fail with these two ladies. New Angels have braved the 'linen area'. The knowledge is being passed along.

Pricing is actually very precise. Condition effects the amounts asked for items and should be as consistent as we can make it. Such good bargains can be had in the linen department of the Sale. I am convinced that someone with a good eye could furnish their apartment or home with very nice, quality linens, at bargain prices. Prized items to receive are christening gowns, handmade quilts, and bed sets which contain matching pillows, shams, dust ruffles, and sheets, and large fine linen table cloths. We do a good business with antique linens, delicate, handstitched handkerchiefs, aprons, and pillow cases.

Our major challenge is discovering the sizes of items brought to us. Sheets need to be categorized as twin, full or double, queen, king and something called a California king. Our job becomes much easier if those items come in labeled already. Flossie has taught me to look for a tag which saves time-consuming measuring, but labels are not always available or readable. **So please label the items you donate, if at all possible!** The newest challenge we have come across is that new mattresses can be much thicker. It's important to have the sizes marked.

So, keep the linens coming into us to sort, fold, price, and pack. We appreciate and enjoy the challenge.

Pat has been an active member of Attic Angel since her Intern (probationary) year in 1982. She received her 30-year Halo Award last year. Her Intern Advisor, Jane McGinn ('75) was a role model and Pat credits her with instilling a strong sense of commitment to the Attic Angel Association and the residents of Attic Angel Place.

Pat fondly recalls the move of the residents from the facility on Segoe Road in Madison to the current facility on Old Sauk Road in Middleton. She reflected on how each resident was assigned an Angel to be their helper during the physical move and to get them oriented to their new surroundings. She hopes that Angels will share the same Angel Touch in making the current and new residents feel at home when they move into the new rooms of the expansion.

One of the main topics that Pat has been speaking to the Intern Classes about for the past 20-25 years is how vital the Interns are to the residents. Since their Intern year has traditionally been concentrated on volunteering in the Health Center/Households, the Interns are the Angels who know those residents closely. For a period in Angel history Interns were allowed to volunteer only in the HC/HH for five years.

While it is fun to "spread your wings" Pat reiterates her feeling that getting to know the residents and interacting with them should be a goal for all newer Angels. She recalls that her Intern Advisor, Jane McGinn, told Pat's class, "You know that the residents are here 365 days a year." This meant to her Interns that there were times when an additional shift of volunteering might mean the world to the resident she interacted with that day. It is so important that we don't respond to a request of a scheduler, in early fall, that, "I have all my hours." We need YOUR help whenever possible. Please call a scheduler if you want to arrange special times.

Pat has chaired the Medical Transport activity since its inception. She is a great model for all Angels and, hopefully, she will be asked to inspire the newly formed Class of 2013 next spring as their Intern year ends.

By the Numbers - with a Cherry on Top!

AAP Expansion News Flash #14

The exterior of the new addition at Attic Angel Place has been wrapped in plastic for many months now. When the building is "unwrapped" this spring, you will see evidence of much creativity, innovation and insight. The new addition looks and feels right for Attic Angel Place right now. This magic didn't happen overnight. Attic Angel has been careful and responsible in undertaking this project to enhance and strengthen the continuum of care offered to residents. Beyond the "feel good" aspects of the project, it's reassuring to look again at the expansion through the lens of the numbers and demographics that undergird the project and underscore its need.

- 1. By 2020 there will be 55 million people over age 65 in the U.S., with 6.5 million of them over age 85. Hence our forward planning to meet the needs and preferences of this changing demographic.
- 2. Ten thousand new Baby Boomers turn 65 each day; they are living longer and gravitating toward facilities that support more active lifestyles. Hence our expanded and remodeled activity and wellness/fitness spaces.
- 3. The number of orthopedic/ joint replacement surgeries is on the rise in the population we serve. On average, 30% of our Health Center residents are admitted for short-term rehab stays (a dramatic increase since Attic Angel Place first opened in 2000). Of these, only 15 to 20% are current residents. The remaining 80-85% come in from the greater Dane County area. Their rehab therapy needs are intense while they are with us and they often return as outpatients to use our rehab facilities. In the past year, we had nearly 150 "healthy discharges" from our 44-bed Health Center, with 80% of these returning to the outside community. Hence our new rehab therapy unit to accommodate increasing demand for these services and to provide convenient drive-up access for outpatient therapy visits.
- 4. In a recent 4-month period, 33 prospective rehab residents were unable to be served in the Health Center because we could not provide them with private rooms. Private rooms can serve those with infection control issues as well as those who otherwise require a private room for receiving cares and maintaining dignity. Unfilled double rooms mean lost revenue. Hence our transition to all private rooms to provide outstanding personal care and services.
- 5. Demand for nursing home beds is declining nationwide, and Wisconsin is not granting additional nursing home bed licenses. (Attic Angel will maintain its 44-bed

license in the nursing home/ Health Center.) At the same time, seniors are looking for cost-effective, agingin-place assisted living solutions that allow them to be proactive in their own healthcare. Hence our addition of 20 new assisted living units to provide additional capacity for this popular level of care.

6. By 2025, the number of people age 65 and older with Alzheimer's disease is estimated to reach 6.7 million nationwide – that's a 30 percent increase from the 5.2 million age 65 and older currently affected. Hence we are redesigning and repurposing Attic Angel Place with maximum flexibility to allow future reconfiguration of the new assisted living units, currently licensed as a Residential Care Apartment Complex (RCAC), into a licensed Community Based Residential Facility (CBRF) if our needs for dementia care increase.

Imagine all of these statistics in a parfait glass – a sort of numerical spumoni ice cream. Now top off the parfait with a dollop of whipped cream, that being the tradition of the Attic Angel Touch, the notion that quality of care and quality of life are inseparable and that we will always do our very best to provide outstanding care in fulfillment of the Attic Angel mission to serve older adults. So what's the cherry on top? It's the donors who are lending their financial support to this project. Our \$1.5 million capital campaign for the Attic Angel Place Expansion Project has surpassed \$1 million. The campaign is running concurrently with the construction project. We're racing to the finish line. You can help with a single gift or a three-year pledge. We're all going to be very proud of this project. Won't you join us?

Each year the Policy Committee is charged with reviewing the Bylaws and/or Policies for all three corporations and making any recommendations of revisions, deletions or additions to the respective Boards.

The committee made a few small changes to the Policy Statements for the Association to improve clarity of their meaning. One major addition was to the Legacy section in which a description and history of the McKenzie Circle and the Mahoney Society were recommended.

A sub-group of the committee continued their work to align all three Attic Angel Corporation Bylaws. Sections were moved, wording was changed and clarifications were made which should make it easier to locate material in each document.
