Pam Lee, Health Center Resident Council Representative, and Cristin Jacque, Social Worker, were the guest speakers this month. Pam Lee, a long term resident, is happy with the new changes and enjoys the Health Center. Jacque gave further details from the staff perspective. Admissions and discharges are at an all-time high as the average stay of rehab patients is 3-5 weeks. The rehab patients are usually more active and more social. They are located primarily in the new wing and that dining room is almost too small right now. Food is now cooked on the floor, plated and served. Residents prefer to be served as soon as they sit down and they like the new procedure. The weekly Happy Hour is popular and families also attend. Previously, the Health Center was primarily long-term residents but with the new wing, the number of rehab patients has grown threefold.

The Board approved the Policy Committee recommendation to add the Director of Activities or the Volunteer Coordinator to the Membership Committee and to add an Attic Sale Steering Committee Chair to the General Nominating Committee.

Every year the Board reviews either the Bylaws or the Policies and this year the Policies will be reviewed at the next meeting.

The Chairs of the Classic Clothing Sale were congratulated on a job well done and thanked for all their hard work. Thanks also to all the Angels who helped make another signature event so successful.

Prairie Point Property Tax Litigation Resolved

Last month I provided information about the agreement reached with the City of Madison and Attic Angel Prairie Point, Inc. relative to property tax litigation. The agreement provides long-awaited clarity for our current and prospective residents relative to property tax status.

The City acknowledges Prairie Point as a Benevolent Retirement Home within the Wisconsin Statutes, and is therefore exempt from future property taxes. Because Prairie Point recognizes the value of the municipal services the city provides, we have voluntarily offered to make payments for those services on an ongoing basis. We have also offered to forego the punitive interest payments on the taxes paid for years 2011-14; which is over \$540,000. The city agreed to withdraw their appeal to the Supreme Court, and repay the taxes paid by Prairie Point.

We received notice last week that the Supreme Court agreed to dismiss the appeal, so that concludes any litigation we have had with the City. The funds have been repaid by City, and the Attic Angel Prairie Point, Inc. Board accepted the recommendation of the Resident Finance Committee to place the majority in the Reserve Replacement Fund; provide a gift to Madison schools of \$200,000, and place the remainder in a Contingency Fund. I greatly appreciate the support, suggestions and efforts of the Prairie Point Board, Prairie Point Resident Finance Committee, and my co-workers in having this matter come to a successful conclusion.

What is Legacy?

Legacy is a recognition program for donors who have shown their support of Attic Angel by giving a planned or major financial gift. Legacy members advance through various categories of membership based upon the cumulative total of their giving. A subset of Legacy is the **Mahoney Society**, a group of people who have included Attic Angel in their wills or estate plans. Attic Angel charitable gift annuitants are also considered to be Mahoney Society members. The Society is named for John Mahoney who gave Attic Angel its first significant estate gift in 1938.
